VI. Committee Updates

Bissell Bros. is also making an effort to follow behind CHP and SSD after they have cleared out a camp to remove as much debris from the site as possible. They continue to report issues to 311. Dump fees that the District is paying was discussed.
- c. Marketing: The banners that are being installed on Watt Ave were discussed. It was suggested that the PBID's website should be overhauled.
- d. County Supervisor Desmond's Office: Vanessa McCarthy-Olmstead reported County is currently formulating the 2022-2023 budget.
